BOOKING TERMS AND CONDITIONS:-

- 1. A booking deposit of €100 must be paid within 7 days of the provisional booking being made. Once the deposit has been paid, the Application will go before the Club Committee for approval. On Approval, the Room Hire Charge of € , and the Cost of the Door Security of € , must be paid in Full at least 14 days prior to the date of the Function. The initial booking deposit will be returned to the applicant shortly after the function date provided no damage has been caused to the Clubhouse or its environs. If the booking is cancelled prior to its taking place, the deposit will be retained by the Club.
- 2. Persons booking the hall will be held jointly and severally responsible for the conduct of all persons attending the function, and will be held accountable and liable for any damage done to the Hall, the Clubhouse, its Furniture and all its Fittings. Decorations must not be affixed with cellotape, Blue Tac, Staples or any other product which might cause damage to the paint or woodwork. Applicants are also reminded that the use of Confetti type products is prohibited within the Clubhouse.
- 3. The Club will be directly responsible for supplying the Door Security personnel for the Function. The Club reserves the right to refuse admission.
- 4. The Consumption of all forms of Alcohol Beverages by persons under the age of 18 is strictly forbidden on the Club's Premises. It is the responsibility of the Applicant to ensure persons consuming alcohol are of legal age (+18yrs). Garda Age Cards & Passports are the only acceptable forms of ID and will be required on the night.
- 5. A minimum number of Adults will be required to attend the Function & the maximum number of persons permitted is 100.
- 6. The Applicant must ensure that all persons attending the Function have left the premises within the terms of the Licensing Laws once the Function has come to an end. Persons leaving the Clubhouse are asked to respect our neighbours and depart in a quiet and orderly manner.
- 7. Under no circumstances may persons attending the Function commit any act that is unlawful (i.e. use of drugs) and such shall warrant removal from the premises.
- 8. In accordance with the current Licensing Laws the Bar will close at 12.30am on Fridays and Saturdays, 11pm on Sundays and 1130pm Mondays to Thursday. All Music/Bands/DJ's must stop once the bar has closed.
- 9. Children may only attend the Function when a 'Substantial' Meal has been served. All Children must remain in the Function Room under parental supervision and may not run around the Clubhouse or Car Park. At no time may they enter the 'Members Bar Area'

10. Visitors attending the Function may not enter the 'Members Bar Area'

- 11. Consideration of this Booking Application is subject to the acceptance by the applicant of these terms and conditions, in recognition of which they should sign hereunder prior to submitting the application.
- 12. All bookings are subject to availability on the date requested and to final approval by the Club's Executive Committee.
